The 'Covid Relief' bill is the greatest expansion of abortion in a decade. Because the Hyde Amendment protections were not included in the bill, billions of dollars of taxpayer money can be used to fund abortion in the U.S. and abroad. The bill spends less than 9% on Covid relief.

Abortion Reporting: Iowa 2019



Changes in Iowa Abortions, 2018 - 2019

Iowa's 2019 abortion statistics were published by the Iowa Department of Public Health in October 2020. According to the report, Iowa abortions increased from the previous year. There were 3,566 abortions reported in Iowa in 2019, an increase of 25 percent from the previous year. Chemical abortions rose by 24 percent, making up two-thirds of all abortions occurring in the state. The Charlotte Lozier Institute (CLI) estimates that Iowa's abortion rate in 2019 was six abortions per 1,000 women ages 15 to 44. Critical Need for More Definitive Coronavirus Vaccines By Alan Moy MD, Founder & Scientific Director of John Paul II Medical Research Institute

Novel coronaviruses have represented a critical and worldwide infectious disease risk for the past two decades. In 2002, a SARS outbreak with a mortality rate of 10 percent broke out in China but was thankfully contained before it spread. In 2012, a MERS outbreak with a 30 percent mortality rate originated in the Middle East, but fortunately this virus was also contained before it spread. Most recently, the COVID-19 outbreak has become a global pandemic that has created a significant public healthcare and economic crisis, despite having a much lower mortality rate. During the prior two decades, research conducted on SARS and MERS failed to result in any vaccines being approved for use. Yet, research that began only during the last year and a half under Operation Warp Speed (OWS) have now resulted in several COVID-19 vaccines being granted an Emergency Use Authorization (EUA) by the Food and Drug Administration (FDA). An EUA means that the FDA is granting drug approval before its clinical trial is complete, based solely on purported early results and an exigent need. Consequently, the currently approved COVID-19 vaccines are not without legitimate scientific concerns, combined with a significant moral and ethical constraint for pro-life individuals.

The Moderna and Pfizer vaccines are utilizing gene therapy to create a synthetic messenger ribonucleic acid (mRNA) to produce the COVID-19 "spike protein." This spike protein is a necessary viral antigen and the first step for the SARS-CoV-2 virus to attach and initiate an infection. While no cell line is required to produce mRNA vaccines, aborted fetal cells were used by several manufacturers in the testing phase of their vaccines. Pfizer and Moderna have claimed that their vaccines are roughly 95 percent effective against COVID-19. However, there is some scientific debate about whether that figure is accurate and may be possibly much lower in preventing infection. Gene therapy vaccines have traditionally faced several scientific shortcomings when used to prevent other viral infections (e.g. HIV) and non-infectious diseases.

First, mRNA vaccines typically exhibit weak immune responses, thereby often requiring a booster injection one month later. Second, the immune protection is limited to defending against one viral antigen, which in this case is the "spike protein." Third, many of these vaccines display uncontrolled dosages and formulations, which carries significant safety risks. It is important to point out that the initial clinical trials conducted by Pfizer and Moderna were performed by primarily selecting only healthy individuals without chronic diseases to be the test subjects. It remains unclear how effective or safe these vaccines will be in the long term when administered to those who are immunocompromised. Published data purports that antibody levels are reduced by up to 70 percent in patients over the age of 70 within three months after completing the immunization schedule. Also, there is little documentation that mRNA vaccines produce the more important T-cell mediated immunity which provides for longer immunity. Thus, it remains unclear whether the more high-risk patients who receive these vaccines are better protected than those who are unvaccinated. Additionally, the incidence of systemic side effects caused by the COVID-19 vaccines seems to be significantly higher than with the flu vaccine. Whether or not mRNA vaccines reduce mortality; the risk of hospitalization; or viral transmission remains unclear because those endpoints have yet to be fully evaluated. One must keep in mind that the recovery rate from COVID-19 for most healthy individuals is over 99 percent.

Pursuant to the shortcomings pointed out above, mRNA vaccines often become ineffective as a virus mutates and new strains emerge. In contrast, traditional vaccines such as attenuated live vaccines deliver potent and more immediate immune protection and offer better crossover protection against other viral strains as mutations arise. Moreover, attenuated live vaccines require no booster injections. While there are currently over 150 world-wide vaccines being developed for COVID-19, very few are using a traditional attenuated live vaccine approach. Attenuated live vaccines typically take more time to develop and require rigorous safety studies in animal models. Unfortunately, for that reason, OWS did not provide financial support to vaccine developers creating a vaccine using attenuated live viruses. (Cont.)

The **John Paul II Medical Research Institute (JP2MRI)** is a 501(c)(3) non-profit organization based in Coralville, Iowa that has developed the largest pipeline of ethical human adult stem cells. The Institute has developed an immortalized human cell line from adult stem cells derived from cord blood. JP2MRI has also developed a synthetic chromosome containing the entire genetic code of the United Kingdom's COVID-19 strain. We are now poised to create an attenuated live vaccine that has the potential to address any novel coronavirus that emerges in the future from China or the Middle East. This ethically developed vaccine will be free of all aborted fetal cell use and testing. However, we need to conduct an exhaustive series of animal studies to validate the vaccine's safety and efficacy. These experiments need to be subcontracted to specialized animal facilities that possess this expertise. As one might expect, such studies are expensive and will cost roughly 2 million dollars to complete.

JP2MRI is pursuing both public and private funding sources to raise the necessary capital to help with our vaccine developmental costs. The Institute has contacted the state of Iowa to seek an appropriations bill and possible funding support from the federal CARES Act. We would welcome all assistance in contacting Governor Reynolds and asking her to support our organization's ethical vaccine development efforts. If we succeed in developing a live attenuated vaccine, it would provide a greatly needed future public healthcare therapy for Iowans and US citizens. Additionally, it would mitigate against future economic and healthcare damages from novel coronaviruses. Finally, it would serve as an important national security measure by protecting against infectious agents and act as a countermeasure against bioterrorism.
